

## *A Life of Faith Girls Club Ministry Agreement*

This Agreement is entered into between Mission City Press, a Texas corporation with offices at 202 Second Avenue South, Franklin, TN 37064 ("MCP"), and the individual or entity named below ("Sponsor"). The parties hereby mutually agree as follows:

1. By accepting this Agreement, Sponsor expresses the desire to provide an *A Life of Faith Girls Club* ministry to young people consistent with the principles expressed by MCP in *A Life of Faith* ("ALOF") products and resources.
2. The term of this Agreement will extend throughout the life of Sponsor's MCP-authorized *A Life of Faith Girls Club*. Either party may terminate this Agreement without cause at any time by giving written notice of such termination to the other party.
3. It is agreed that all copyrights, trademarks, trade names, service marks, and similar proprietary rights in and to the *A Life of Faith Girls Club* program and any and all materials, methods, products, and resources associated with the *A Life of Faith Girls Club* program (together herein referred to as the "A Life of Faith Property") are owned solely and exclusively by MCP. This includes, among other things, the following MCP trademarks: *A Life of Faith*, *A Life of Faith Girls Club*, *Elsie Dinsmore*, *Millie Keith*, *Violet Travilla*, *Laylie Colbert*, *Kathleen McKenzie*, and others.
4. Sponsor expressly acknowledges MCP's sole and exclusive ownership of the A Life of Faith Property and agrees not to contest MCP's ownership or to take any action inconsistent with MCP's ownership. All uses of the A Life of Faith Property in connection with Sponsor's *A Life of Faith Girls Club* program will accrue to the benefit of MCP, and the copyrights and trademarks in any items incorporating the A Life of Faith Property will become the exclusive property of MCP. If any item incorporating the A Life of Faith Property is displayed or distributed outside of an actual Club setting (for example, on promotional fliers), please include the following notice: "All *A Life of Faith* related trademarks and copyrights are the exclusive property of Mission City Press. Used by permission."
5. MCP reserves quality control rights with respect to all uses of the A Life of Faith Property, and will have the right to require Sponsor to cease use of an item if MCP, in its sole discretion, feels its nature or quality is inconsistent with the A Life of Faith Property or not in its best interests. Sponsor understands and agrees that Sponsor may use the A Life of Faith Property only while this Agreement is in effect and *only* for the purpose of promoting and conducting a MCP-authorized *A Life of Faith Girls Club*.
6. Sponsor may use text, artwork, and logos from the ALOF web site at [www.alifeoffaith.com](http://www.alifeoffaith.com) and from the *A Life of Faith* clip art CD-Rom in order to make crafts and novelties for Club use (such as buttons and bookmarks), however these items may only be used for free, Club-related, ministry distribution. Sponsor is not permitted to commercially produce or sell any items incorporating the A Life of Faith Property. Club members may, however, chip in to cover out-of-pocket expenses for the supplies needed to make the items. Sponsor agrees to send samples of items to MCP for MCP's Club scrapbook and so that MCP can share the ideas with other Club leaders. Sponsor agrees not to charge members dues or membership fees, but Sponsor may suggest a donation to cover Club expenses.
7. Sponsor agrees not to use the A Life of Faith Property in the publication of stories, articles or other materials for any purpose other than the promotion of Sponsor's local *A Life of Faith Girls Club* program. Sponsor agrees not to use the A Life of Faith Property in any way following expiration or termination of this Agreement.
8. Sponsor's *A Life of Faith Girls Club* program exists as a ministry of Sponsor. Sponsor shall be solely responsible for all aspects of Sponsor's local *A Life of Faith Girls Club* program, including but not limited to operating the local program, the safety of participants under relevant law, and all screening, hiring, training, supervising, and other personnel matters concerning any volunteer or employed leaders and staff involved in Sponsor's *A Life of Faith Girls Club* program. Sponsor and MCP acknowledge and agree that:
  - a. Nothing in this Agreement will be construed to make the parties joint venturers or legal partners, or to permit either party to bind the other to any commitment or to act on the other's behalf. Their status is that of an independent purchaser/licensee (Sponsor) and a seller/licensor (MCP) of products, programs, materials, and services.
